December 11th, A. L. 5810.

At a meeting of delegates, in convention, from the lodges in the District of Columbia, for the purpose of considering the right and expediency of establishing and organizing a Grand Lodge in and for said District,

Were present:

From Federal Lodge, No. 15—Brothers Alexander McCormick, Patrick Magruder, C. Willis Weaver, Archd. Van Horn, and Charles Glover.

From Alexandria Brooke Lodge, No. 47—Brothers James Galt, Amos Alexander, and James Carson.

From Columbia Lodge, No. 3—Brothers Charles Jones, Orlando Cooke, and Ninian Beall.

From Washington Naval Lodge, No. 41—Brothers John Davis, of Abel; Shadrach Davis, Joseph Cassin, James Kemp, and David Dobbyn.

From Potomac Lodge, No. 4—Brothers Henry Pyfer, Daniel Kurtz, and Lewis P. W. Balch.

When Brother Alexander McCormick was chosen chairman and Brother Charles Glover secretary.

Resolved unanimously, That it is right and expedient to establish and organize a Grand Lodge in and for the District of Columbia.

Resolved, That a copy of the proceedings of this convention be sent by the Secretary to the several lodges in the District, and that they be requested to appoint deputies in convention on the second Tuesday of January next, at 3 o'clock p. m., at the Union Lodge room, in the city of Washington, with full

powers to form a Grand Lodge and elect and install Grand Officers.

The convention then closed.

CITY OF WASHINGTON, D. C.,

8th January, A. L. 5811.

At a meeting, in convention, of deputies from the lodges in the District of Columbia, for the purpose of organizing and establishing a Grand Lodge for said District, delegates, with full powers, from five lodges being present, it was

Resolved, That the installed officers of the Grand Lodge for the District of Columbia be a Grand Master, a Deputy Grand Master, Grand Senior Warden, Grand Junior Warden, Grand Secretary, and Grand Treasurer, to be elected by ballot (the deputation from each lodge to have one vote), who shall be the officers of the said Grand Lodge until the first day of January, A. L. 5812, unless in case of death, removal, or inability to serve; in such case the vacancy to be filled at the next meeting of the Grand Lodge for the remainder of the term, and that not more than one of the five first named officers shall be chosen from the same lodge.

The convention then proceeded to elect officers agreeably to the above resolution, when it appeared that the following brethren were appointed, viz:

Valentine Reintzel, R. W. G. Master.

John Kinkaid, R. W. D. G. Master.

Alexander McCormick, R. W. Senior G. Warden.

Joseph Cassin, Jr., R. W. Junior G. Warden.

Charles Jones, R. W. G. Secretary.

The appointment of Grand Treasurer was postponed until the next meeting.

Resolved, That when this convention adjourn it do adjourn until the second Tuesday in February next.

Resolved, That a committee of five be appointed to prepare and report a constitution for the Grand Lodge of the District of Columbia, and that they report the same at the next meeting.

Which said committee was accordingly appointed.

Resolved, That the Secretary of this convention be requested to forward to the Secretaries of the Grand Lodges of Maryland and Virginia a copy of the proceedings, to be by them laid before their respective lodges, or the Grand Officers thereof.

The convention then adjourned.

At an adjourned meeting of the delegates from the lodges in the District of Columbia, were present the delegates from all the lodges but Washington Naval Lodge, No. 41. When by consent the convention adjourned until Tuesday next, 4 o'clock p. m.

19th day of February, A. L. 5811.

The convention met pursuant to adjournment, deputies from the several lodges being present. The convention proceeded to ballot for a Deputy Grand

Master, to fill the vacancy occasioned by the death of Brother John Kinkaid, when Brother John Richards was duly elected.

The convention then proceeded to the election of a Grand Treasurer, when Brother John Davis, of Abel, was duly elected.

The Secretary reported that he had, agreeably to a resolution of the 8th January, "forwarded to the Secretaries of the Grand Lodges of Maryland and Virginia a copy of the proceedings, to be by them laid before their respective lodges or the Grand Officers thereof," accompanied with the following letter:

In obedience to the directions of a convention composed of deputies from five lodges in the District of Columbia, I enclose to you a copy of their proceedings, to be laid before the Stewards and the Grand Lodges of Maryland and Virginia, or the Grand Officers thereof. The reasons which influenced the lodges here in their proceedings you may expect will be fully communicated to you after the next meeting of the convention, which will be on the second Tuesday of February next. In the mean time I will take the liberty of stating that they were not actuated by any motive unfriendly to the mother lodges, under whose warrants they worked, but from considerations resulting from the assumption of the jurisdiction by Congress over the District of Columbia, there being four lodges in that part of the District called Washington county, and two in that part called Alexandria county. You will readily see the importance of uniting the lodges in a district situated as this is, and that uniformity and harmony in their proceedings will be promoted by the formation of a Grand Lodge.

I feel authorized in stating that it is the wish of the lodges here to retain the warrants under which they now work, and that it is their intention to settle their accounts with the different Grand Lodges to such time as may be agreed on.

It will give me great pleasure to have the receipt of this acknowledged before the next meeting of the convention, with such information as may be thought necessary to communicate.

The Grand Lodge then proceeded to the election of a Grand Tyler, when it appeared that Brother Thomas Summers was duly elected.

The committee appointed to prepare and report a constitution for the Grand Lodge made their report, which was taken into consideration; and having made some progress therein, the further consideration thereof was postponed until the next meeting.

Ordered, That the Grand Secretary prepare warrants for the several lodges under the jurisdiction of this Grand Lodge, by such name, and to such officers as the said lodges shall respectively request; said warrants to bear date this day, and to have therein inserted, "late Lodge, No., working under the authority of a warrant from the Grand Lodge of" (Maryland or

Virginia, as the case may be), and to be authenticated, agreeably to the provisions of the by-laws, and in case two lodges shall make choice of the same name, the senior lodge to have the preference.

It is further ordered, That Brethren Alexander McCormick, James Carson, Charles Jones, John Davis, of Abel, and Alexander L. Joncherez be a committee to regulate and fix on the form of said warrants.

Resolved, That the Grand Secretary inform the W. Master, of Alexandria Washington Lodge, No. 22, that we have formed and constituted a Grand Lodge for the District of Columbia, respectfully inviting them to join and send delegates to represent them at our next meeting.

The Grand Lodge then closed to meet again on the second Tuesday in March next.

Brother Charles Jones, Grand Secretary-elect, appeared and was installed according to ancient form and ceremony, and duly proclaimed as such.

Resolved, That the officers of the several lodges be installed at their respective lodge rooms, with the assistance of some installed Grand Officer.

The Grand Lodge was then closed in harmony, to meet again on the 9th day of April next.

ALEXANDRIA, 9th April, 1811.

Respected Brother:

I received your favor enclosing the resolution of the Grand Lodge of the District of Columbia, and laid the same before Alexandria Washington Lodge, No. 22, and am sorry to inform you that there is a majority of that lodge unwilling to withdraw themselves from the Grand Lodge of Virginia, and for the purpose of harmony among ourselves the lodge has declined sending a deputation to your installation this evening.

Resolved, That a committee of three be appointed for the purpose of informing the R. W. Grand Lodges of Maryland and Virginia that we have organized and established a Grand Lodge for the District of Columbia, giving our reasons therefor, and that they request their concurrence therein.

Accordingly, Brothers Balch, Alexander and Glover were appointed the committee.

The delegates from the several lodges presented the names of their officers, and the names and numbers of their lodges, and prayed that warrants should issue accordingly, which was concurred in.

A due representation from four lodges being present, the Grand Lodge proceeded to business.

The committee appointed for that purpose reported that they had prepared and transmitted an address to the Grand Lodges of Maryland and Virginia, as follows, viz:

— — —, R. W. Grand Master of the Grand Lodge of — — —:
Respected Sir and Brother:

When it becomes necessary that a separation should take place with those who have long been united in the tender ties of mutual harmony and intercourse a sense of gratitude and esteem should impel those who desire that separation freely to declare the reasons by which they are actuated. Under this impression we, in behalf of the Grand Lodge of the District of Columbia, beg leave to state the reasons which influenced the lodges in this District in the measure by them taken.

The right and expediency of establishing a Grand Lodge in this District had for a considerable time engaged the attention of the most experienced Masons of this place. Not willing, however, to confide implicitly in their own judgments in a matter of so much importance, experienced Masons from various parts of the United States were consulted, from the decisive nature of whose opinion the practicability of the measure appeared manifest. And at a meeting in convention of deputies from five lodges, after mature consideration, the right and expediency was unanimously

declared; and afterward, on the 19th day of February, 1811, the Grand Lodge of the District of Columbia was organized and opened in due form, with full appellat and corrective powers, which, under the superintending care and direction of the Supreme Architect, will promote the interests of the craft and extend the empire of Masonry. The propriety of the measure taken was confirmed by a reference to historic facts. In England Masonry flourished but partially until the organization of the Grand Lodge at York, from which time Masonry, literature, arts, and sciences flourished. The same fruitful source of intelligence extending its benign influence across the Atlantic animated our brethren of the Eastern States, who organized Grand Lodges previous to our Revolution, under the authority of charters granted from some one of the Grand Lodges in Great Britain, after which they at once saw the impropriety of working under authority derived from a country having different laws, government, and interests from their own, and accordingly gave up the authority under which they had before acted. There then being no head to resort to, the subordinate lodges of several States, by deputies appointed for that purpose, organized Grand Lodges. It is admitted that necessity urged the adoption of this measure, and that the principle was then acknowledged, and has never since been disputed, and that the lodges of each State were entitled to equal privileges. This District being composed of parts of two States, and separated from them in the same degree as one State is from another, was a circumstance that received considerable weight, in addition to which the desire of uniting and harmonizing the citizens of a district thus situated—the expenses and dues retained among us, and the facility of decision in cases within the jurisdiction of a Grand Lodge, were circumstances that received the consideration due to their importance. Also, this being the seat of government, it was supposed the most proper place to rear the standard of Masonry, that the enlightened and distinguished men of our country may meet and unite in one general system the several Grand Lodges in the United States.

The lodges here have been directed to return the warrants under which they lately worked to the authority from whom they received them, if required, and to settle their accounts. This will be attended to without delay, and experience leads us to believe that when the subject of our proceedings shall be taken into consideration our motives and conduct will receive the sanction of your approbation.

We cannot on this occasion withdraw from you without experiencing those feelings of regret which flow from a lively recollec-

tion of favors bestowed on us for a series of years, and expressing that ardent anxiety for your prosperity which will ever animate our hearts. The sensibility of our feelings is, however, somewhat assuaged with the hope that the strong claim of love will forever be preserved bright between us, and that all our designs and all our exertions will tend to promote the general good.

A printed communication was received from the Grand Secretary of the Grand Lodge of Maryland, from which the following is an extract, viz:

The Committee of Communication reported that they have attentively read and considered the communications and proceedings of the Grand Lodge in the District of Columbia and find the same to be conformable to the ancient rules and landmarks of Masonry. Your committee, therefore, recommend the following resolution:

“Resolved, That the several lodges composing the Grand Lodge in the District of Columbia, and heretofore working under the authority of this Grand Lodge, be permitted, according to their desire, to retain their warrants; and that, upon the several lodges paying all their dues up to the time of this grand communication, except initiation fees from the time of their formation of said Grand Lodge, they be recognized as a Grand Lodge, and admitted into correspondence accordingly.”

The committee appointed for that purpose reported the constitution of the Grand Lodge, with amendments; the same was taken into consideration, was further amended and finally adopted as the constitution of this Grand Lodge.

Brother Samuel B. Ellis and five others, all of whom are Master Masons, presented a petition for a warrant to form a new lodge at Washington City, to

be called Union Lodge, No. 6. The same was taken into consideration, granted, and a warrant ordered to issue to Sam'l B. Ellis, Master, William H. Ward, Senior Warden, and William Wood, Junior Warden.

The Grand Steward presented his account, which was examined and ordered to be paid by the Grand Treasurer.

Ordered, That the Grand Secretary cause one hundred copies of the constitution of this Grand Lodge to be printed, and that he furnish the lodges under this jurisdiction with a copy thereof.

The Grand Lodge was then closed in ample form and harmony.

Resolved, That a committee be appointed to report to this Lodge what provision is necessary to be made in relation to the appointment of a deputation to meet such other deputies as may be appointed by the several Grand Lodges in the United States, to assemble in grand convention.

Brothers Charles Glover and Amos Alexander were accordingly appointed that committee.

Brother Charles Glover, from said committee, reported the following preamble and resolutions, which were unanimously adopted:

It appears to this Grand Lodge that several of the Grand Lodges in the United States have been desirous of meeting in grand convention by deputies from the said lodges: Therefore

Resolved, That a deputation be appointed by this Grand Lodge to meet in convention such deputies as may be appointed by the said several Grand Lodges, on the 4th Monday of January next, or such other day as may be agreed on, in the city of Washington.

Resolved, That the Grand Secretary cause the foregoing resolution to be published in the National Intelligencer for six weeks.

The Grand Lodge proceeded to ballot for five deputies to represent them in grand convention, and on counting the same it appeared that Brothers Valentine Reintzel, John Richards, Alexander McCormick, Joseph Cassin, and Amos Alexander were duly elected.

On motion,

Resolved, That the Grand Secretary forward to the different Grand Lodges throughout the United States a copy of the foregoing resolutions, and inform them of the nomination of delegates to the grand convention this day made, and offer them the use of the hall, tools, and jewels belonging to this Grand Lodge.

The following petition was received and read, viz:

To the Right Worshipful the Grand Lodge
of the District of Columbia:

The subscribers beg leave to represent that they are Master Masons and are now members of Federal Lodge, No. 1, working under your jurisdiction; that they have the highest veneration for the principles of the Craft, and are desirous of diffusing those principles according to the ancient usage and custom of the fraternity;

They therefore humbly petition your Right Worshipful Grand Lodge to grant them a warrant or charter by the name of Lebanon Lodge, No. 7, authorizing and empowering them to work as a Lodge of Masons, according to the most ancient and honorable principles of the Craft, within the city of Washington.

Should their petition be granted, they promise to conform to all the orders and regulations that have been or hereafter may be

made by your Right Worsbipful Grand Lodge. And in order to carry into effect the object of their petition, they beg leave to recommend Charles Glover as Worshipful Master, James Hewitt as Senior Warden, and John Weightman as Junior Warden of the said lodge.
